1. Call to Order and Approval of Agenda

The Chair called the meeting to order.

It was moved, seconded, and carried that the agenda be approved.

2. Chair of Council's Remarks

The Chair welcomed members to the 63rd meeting of Council.

The Chair reminded Councilors that at the last meeting of Council, members asked for an opportunity to have more input on SMA2. The Chair noted that the Academic Policy and Planning Committee will report on the discussion APPC had on SMA2. The Executive Committee has also assigned the SMA2 to be the May Council meeting's Collegial Conversation topic. The Chair also noted that The Executive Committee has recommended that the Committee on Research Policy and Planning create a sub-committee working group to examine what would be the appropriate metrics for the Social Sciences and Humanities. The Chair mentioned that in the December meeting of Council, a lot of issues were raised concerning e-voting. These concerns were taken to the Executive Committee for further discussion, and a hard copy fact sheet has been created addressing some issues raised. She informed Councilors that the assigned topic for the Collegial Conversations is e-voting.

The Chair reported that Senate has requested that the Final Assessment Reports for Cyclical Program Reviews be circulated to Councilors. It can be found in the agenda package.

The Chair also mentioned that there will be a presentation on sustainable energy from the Chair of the President's Sustainability Council.

3. Minutes of the March 9, 2017 Meeting

J. Edmondson moved, seconded by A. Weiss that the minutes of the March 9, 2017 meeting be approved. The motion carried.

4. Business Arising from the Minutes

There was none.

5. Dean's Report to Council

It was noted that due to a family emergency the Dean will not be in attendance.

6. Question Period

It was noted that any questions for the Dean would be communicated to her. There were none.

7. Reports from Standing Committees of Council

Executive Committee

The Vice-Chair presented the Executive Committee Report. He informed Councilors that the slate of nominees can be found in the agenda package. The Vice Chair then opened the floor for nominations for Council Standing Committees. A Councilor asked if there was an advantage to closing the nominations now

compared to extending the deadline. The Vice Chair noted that we should get members in place as soon as possible and to vote on vacancies.

R. Grinspun nominated himself for one of the vacancies on the Executive Committee.

The Vice Chair moved, seconded by R. Koleszar-Green, to close the nominations for Council's Standing Committees. Motion carried.

The Vice Chair opened the floor for nominations for Senate's Academic Policy, Planning and Research Committee. The Vice Chair moved, seconded by G. Vanstone, to close nominations for Senate's APPRC. Motion carried.

The Vice Chair informed Councilors that the Executive Committee agreed to postpone the closure of nominations for LA&PS Representatives on Senate pending Senate's vote on Senate membership for 2017-2019, which is scheduled to take place on April 27, 2017.

• Committee on Curriculum, Curricular Policy and Standards

A. Weiss, Chair of CCPS, presented the report. He noted that there is an amendment to the Certification on Nonprofit and Cooperative Management. It is a cross-disciplinary certificate, not a professional certificate.

A. Weiss also noted that the revision to the consultation on AP/SOSC 4001 6.00 has been included in this month's CCPS report.

Academic Policy and Planning Committee

S. Kheraj, Chair of APPC, presented the report. He informed Councilors that the discussion at the last APPC meeting, the committee focused primarily on five indicators of metrics that will hopefully highlight the university-faculty strengths and aspirations. The indicators are as follows:

- Student experience
- Innovation in teaching and learning experience
- o Access and equity

- Research excellence and impact (limited discussion of this topic as it was covered in a previous meeting)
- Innovation, economics development, and community engagement

S. Kheraj discussed with Councilors the five indicator categories and what weight each category should be given, as the Dean will need to present on the idea of how the university should be weighing each of these categories.

A Councilor asked if this report will be sent to VP Hache and when they could expect to hear a response from him more directly. He asked the Chair to explain where this goes from here and what the process is.

S. Kheraj replied that from his understanding, they (APPC) provide feedback to the Dean who represents LA&PS and makes the Faculty's case to VPRI.

A Councilor asked if it has been established how the Dean will come to a decision.

The Chair of Council noted that the Dean, at the Executive Committee meeting, explained that a draft will be prepared for Senate and the Provost, and then the subsequent information from the May Council meeting will be taken to the Provost.

A Councilor clarified that the five categories include but are not limited to research. There are other elements and there are other elements to consider.

A Councilor noted that there are a number of discussions taking place across the university. He believes universities across the province are trying to respond as best as they can. In our case, the Provost is going to provide the comprehensive response, and he hopes it will be done in ways that are inclusive and that the process leading to that is participatory, reflecting the full input from various faculties. He also noted that the effort to introduce indicators at various levels is broader than just the strategic mandate.

S. Kheraj noted that they are only being asked to come up with better ways to quantify our research and not whether quantification of our research is the appropriate way.

The Chair of Council stated that all the comments will go back to the Dean.

8. Report from Senate: Final Assessment Reports for Cyclical Program Reviews

The Chair noted in her opening remarks that the report from Senate is available for Councilor's to review on page 17 of the agenda package.

9. Presentation

Professor Martin Bunch, Chair of the President's Sustainability Council gave a presentation on York's sustainability strategy.

Councilors were invited to ask questions after the presentation.

A Councilor noted that normally, when one tree is removed it had to be replaced with two trees. He asked if this is a principal that is applied across campus, since he has noticed that two dozen trees have been removed off Chimneystack Rd. M. Bunch replied that yes that was his understanding.

Another Councilor asked what is measured in terms of greenhouse emissions, to assess the university's contribution? M. Bunch noted that they have a cogeneration plant on campus, so they know how much natural gas they burn and calculate greenhouse gas emissions. They also calculate how much petrol the university consumes.

A Councilor commented that a good idea would be to sell empty water bottles on campus, so that when someone needs water, they are not required to buy water, but can rather buy an empty bottle and fill it. M. Bunch noted that this topic has come up, mostly in relation to students coming on campus who need options. The idea so far is providing free water bottles during recruitment events. He noted there is no solid solution yet but they are open to suggestions.

A Councilor inquired about community engagement efforts, and asked if M. Bunch can elaborate on areas around community planning. M. Bunch stated that the Jane Finch neighborhood is their main focus. He noted that York has a memorandum of understanding with Blackwood Creek Farm as well, and there goal is to engage community members on campus.

A Councilor asked what the impacts of the subway station on campus. M. Bunch replied that their expectation is that it will improve the university's ratio of sustainable modes of transportation on campus. There are some glitches, such as people coming from York Region. They would normally take York Region Transit (YRT) and pay one fare, but with the new system it would require they pay two fares. This may affect people's transportation choices. Also, the GO station east of York is being closed down. There are concerns surrounding what happens to those networks.

A Councilor asked if the university is doing green roofs, and if not, can it be done. M. Bunch listed a number of green roofs that are currently in place and noted that they intend to create more.

A Councilor asked if the committee addresses employment sustainability in terms of food services. M. Bunch noted that employment is a step removed from what they can comment on.

10. Collegial Conversations: E-voting

The Chair of Council noted that the Executive Committee has put together a list of eight issues posed as questions with answers where possible directly from Rules and Procedures of Faculty Council or Senate.

The Chair noted that the main argument is whether they are in favour or against electronic voting. The fact sheet prepared lists comments taken from the December meeting of Council and clarified two aspects with respect to voting. She noted that electronic voting is not currently recognized under the Rules and Procedures. Where rules are silent in the Rules and Procedures of Council, Council may refer to Senate's Rules and Procedures. Senate rules state that in exceptional circumstances, the Executive Committee may authorize electronic voting. Faculty Council's rules are silent but Senate rules explicitly allow for the Executive Committee to authorize exceptional circumstances for e-voting. Another question that arises is how it will be decided which motions are taken to an electronic vote. She noted that issue number 8 summarizes what would be done should they adopt university Senate rules wherein the Executive Committee could identify which motions could be taken to an electronic vote. In the event Council opposes the Executive Committee's decision, with a motion from the floor to overturn the recommendation and have a vote from the floor.

A Councilor claimed that the statement made on the Council's Rules and Procedures being silent on electronic voting is incorrect.

The Chair noted that Senate has a similar rule for voting and separately have recognized that the Executive Committee may authorize electronic voting, and this is her interpretation of the rules.

S. Kheraj moves, seconded by T. Maley that Council moves into Committee of the Whole for an open discussion about e-voting. All in favour, motion carried.

A Councilor noted that by focusing on engagement and participation in government and accessibility to everyone regardless of whether they can be present or not, e-voting is a good approach. This does not address the issue of the culture of people not engaging. It is more important to focus on how to get more people engaged, such as streaming Council meetings, or creating an interactive way people not present can engage in the discussion. We need to think about progression of technology can allow us to do that.

A Councilor noted that he did some research and got an understanding on how other universities handle this. He noted that there appears to be no precedence of this anywhere across the country. He noted that we should be careful and clear how dangerous this is- encouraging people not to attend Council and not be engaged. There is no way you can replicate a debate using an evote. He noted that Senate rules are very clear. Faculty Council may cite Senate rules for disposition of an issue not adequately addressed in their own Rules and Procedures. Senate allows Faculty Council to lean on their rules, only if they are not clear, and in this particular case Faculty Council cannot lean on Senate's rules.

A Councilor noted that article 5.1 of the Rules and Procedures is clear about members being present and voting. Ad Hoc is trying to address this in their report. In this case, why is a parallel structure needed? E-voting has rarely been used in Senate deliberations.

A Councilor noted that in order to use e-voting, we would have to change the Rules and Procedures. If Council decides to go this way, there is a model at Senate that we could use, but do not have to. This does work against participation rather in favour of it. It would need to be used in truly exceptional circumstances and the decision should be taken by the body rather than the Executive Committee.

A Councilor commented that the Rules and Procedures of Council are abundantly clear about voting procedures. It is more important to focus on the pros and cons of electronic voting rather than the legality and legitimacy of it.

A Councilor noted that this Faculty has 600 members and professors teach during Faculty Council thus they cannot attend. There is an illusion that we have this democratic forum that allows for full participation. We need to focus on finding some way to ensure more members are able to participate.

A Councilor commented that if we want e-voting, we must find the best procedural way to implement it. E-voting raises more problems than it fixes, no one will attend Council if they know they can stay home and vote.

A member noted that if you leave out debate, the quality of decision goes down the tube. A summary of a discussion is not good enough, and then we will need rules about who gets to summarize. No one is using e-voting and for good reason

Moving out of the Committee of the Whole, the Vice-Chair thanked members for their comments.

11. Other Business

There is no other business.

Executive Committee Report to Council

ITEM FOR ACTION (2)

1. Motion: Importing Language from Senate Rules & Procedures on Transaction of Business by Electronic Communication

The Executive Committee makes the following statutory motion:

That LA&PS amends its Rules and Procedures to explicitly import the following language from the Senate Rules and Procedures [Section A, IV.11]:

Transaction of Business by Electronic Communications

- a. In exceptional circumstances, the Executive Committee may authorize the transaction of [Council] business by electronic communications. This may include the transmittal of reports or the conducting of votes on [Council] business. The Executive Committee will provide a rationale for its authorizations.
- b. For the purpose of requesting a special meeting of Senate, individual petitioners may send an electronic communication in lieu of signing a petition.
- c. [Council] committees may transact business by means of electronic communications.

Rationale

The proposed motion adopts the Senate language on the use of electronic communications, including the conducting of votes in exceptional circumstances. As such, it significantly scales back an earlier motion focused on introducing electronic voting in more and specified instances (provided as a Notice of Motion in the November 2016 meeting of Council). This substantial revision is in response to the significant feedback from our discussions at the December and April Faculty Council meetings.

The LA&PS Council and Standing Committees currently uses electronic communication to conduct routine business and in some situations uses electronic voting as well (voting for members on Standing Committees and representatives on Senate, for example). At present, though, the LA&PS Council Rules and Procedures are silent on the use of electronic communications and on electronic voting.¹ The Executive Committee believes that for clarity and transparency it is preferable to specify explicitly in its own Rules and Procedures the use of electronic means for transacting the business of Council.

As regards voting, the LA&PS Rules and Procedures state that "All questions that come before Council shall be decided by a majority vote of the members present and voting unless otherwise indicated or specified" [Article 4.5]. The Senate Rules and Procedures are similarly

and explicitly confined, dictating that "Unless otherwise specified by the Executive Committee or Senate, voting is conducted by a show of name placards" [Section A, V. 2(e)].

In both documents, it is anticipated that under exceptional circumstances voting in some other manner (including, for example, secret ballot) might be advised. Further, Senate rules separately and explicitly acknowledge the use of electronic voting in exceptional circumstances (Section A, IV.11).

The motion here proposes LA&PS Rules & Procedures adopt explicitly the Senate rule that has justified current Council practice.

It should be noted that all other rules apply, in particular, quorum for voting remains the same: At least half of the voting members of the Committee, the majority of whom are full-time faculty members (LA&PS Faculty Council Rules and Procedures, 3.3)

For these reasons the above motion is proposed to amend the LA&PS Faculty Council Rules and Procedures. In order to carry, this motion requires a two-thirds majority of members present and voting (LA&PS Faculty Council Rules and Procedures, 5i).

2. Closure of Nominations: LA&PS Representatives on Senate

At the April 27, 2017 meeting of Senate, a motion to amend the distribution of Faculty Council members on Senate for the period of July 1, 2017- June 30, 2019 was approved. Previously, LA&PS held 40 seats on Senate. As of July 1, 2017, the number of LA&PS representatives on Senate will be 37 (minimum 13 Chairs and 2 contract faculty members). As such, there are currently no vacancies on Senate, and we no longer require nominations. We thank the Councilors who were nominated to represent LA&PS on Senate and ask that they consider putting their name forward for our Standing Committee vacancies in fall.

The Executive Committee moves to close the nominations and approve the current slate of LA&PS representatives on Senate. The list of Senators can be found in Appendix A of this report.

ITEMS FOR INFORMATION (2)

1. Standing Committees & Representatives on Senate APPRC Election Results

An election (e-vote) was held for those committees for which there are a greater number of nominees than vacancies. Paper ballots were also available in the Office of the Faculty Council. The election ran from Monday May 1, 2017 until Saturday May 6, 2017 inclusive.

A full listing of the memberships for each of the Standing Committees of Council and LA&PS representatives on Senate APPRC may be found on Appendix A of this report. It contains the names of the elected and acclaimed members for each of the Standing Committees of council and representatives on Senate APPRC.

Thank you for your memo of April 25, 2017 requesting more information about the Executive Committee's recommendation that the Committee on Research Policy and Planning create a Working Group for exploring research metrics appropriate to the social sciences and humanities.

As you know, Councilors have expressed considerable concern about the various ways in which current bibliometrics do not properly account for work produced in the Social Sciences and Humanities. In its February 2017 meeting, Council passed the following motion to this effect.

LA&PS Council would like to express its dissatisfaction with the use of simple metric indicators to evaluate scholarly work in our Faculty and expresses concern about the well-known shortcomings and perverse effects of such metrics on scholarship, particularly in humanities, social sciences and interdisciplinary research. We urge the Office of the Vice President Research & Innovation to work with us toward the creation of a more appropriate way of capturing the diversity of our research.

Responsive to Council's motion and other feedback from our February 2017 Faculty Council *Collegial Conversation* on 'Research Indicators', the Executive Committee followed through with its suggestion to create a Working Group for exploring this issue. In its capacity to oversee the business of Council – the body that structures collegial governance in the Faculty of LA&PS – the Executive thought it best to take its recommendation to your committee. As articulated in CRPP's mandate, the Committee shall "Constitute sub-committees for research adjudications, and from time to time establish ad hoc working groups to deal with emerging priorities in relation to research and scholarship".

Recognizing that the CRPP is best positioned to decide the terms of reference and mandate of any working group it might create, I provide nevertheless and on your

request, suggestions to be considered in the CRPP's framing of the Terms of Reference, Composition and Reporting of the Working Group (WG).

The WG might consider the following elements in the drafting of its Terms of Reference:

- Under the auspices of the CRPP, the WG would act in an advisory capacity to Council proposing a set of research metrics appropriate to reflecting the breadth of research conducted by our colleagues in the social sciences and humanities particularly
- It might review existing research metrics at York and elsewhere as a means of informing its assessment of recommended metrics
- It would expectedly want to liaise with relevant units, including departments/schools within LA&PS, as well as the Senate Academic Policy Planning and Research Committee for input and feedback
- It would set a timeline for the operation of the WG
- The WG may opt to refine its own Terms of Reference within the broader mandate to provide a recommendation to Council on appropriate research metrics

The WG might consider composing the WG of the following individuals

- 1 or 2 representatives from the CRPP
- 3 or 4 other faculty members, including at least one member from a humanities unit, one from a social sciences unit, and one from a professional unit
- Associate Dean Research
- Vice President Research and Innovation, or delegate
- Additional members as the CRPP deems advisable

Its report to the CRPP would inform a communication to Council that would, in turn, inform a communication to the Senate APPRC and Vice President Research summarizing the recommendations of LA&PS for research metrics that appropriately reflect the importance of social sciences and humanities research conducted in our faculty.
