#### 1. Call to Order and Approval of Agenda

The meeting was called to order. It was moved, seconded, and carried that the agenda be approved.

#### 2. Chair of Council's Remarks

The Chair welcomed members to the 51<sup>st</sup> meeting of Council and wished everyone a Happy New Year!

She thanked Professor Thaddeus Hwong for having chaired the December meeting of Council during her absence and also thanked Professor Ida Ferrara for kindly stepping in as acting Vice-Chair.

The Chair shared that a landmark agreement on climate change was reached in Paris, which opens a new path for the world for making forward progress.

As the year begins, the Chair took a few moments to take stock and to reflect on the goals for the New Year. She noted that the Faculty Council had a productive Fall term, and that she looks forward to working together in months ahead. She noted: "*In my role as Chair, I will continue to promote a truly inclusive, transparent, and collegial environment. We are working to look for ways of improving our communication with the membership as well as enhancing engagement.*"

The Chair then announced that at this Council meeting there will be special presentations from our students as well as from the Ad Hoc Governance Committee.

She also mentioned that the President will be in attendance at February's Council.

There was no request to move items off of the consent agenda, these items were deemed approved.

#### 3. Minutes of the December 3, 2015 Meeting

It was moved, seconded, and carried that the minutes of the December 3, 2015 meeting be approved.

#### 4. Business Arising from the Minutes

There was none.

### 5. Dean's Report to Council: Academic Planning: First Responses from LA&PS Schools and Departments.

Dean Mukherjee-Reed presented on the feedback received from Departments and Schools on what they would like to see in the Faculty and University Academic Plans. This included the renewed call for centrality of the liberal arts in university education, access and inclusion, renewed emphasis on traditional pedagogy, a rigorous and elaborate policy framework for e-learning, and support for a full range of experiential education opportunities suited to our student demographics.

The Dean also mentioned the comments on resources, which included workloads consistent with premier research universities, complement renewal, support for enhancing student experience, and physical space.

Additionally, she highlighted the responses regarding the Faculty's goals, which involve:

- Strengthening and renewing our leadership in critical, interdisciplinary, liberal arts education;
- Maximizing the potential of our professional programs (and support their distinctiveness);
- Creating the best synergy between liberal and professional education, between scholarship and practice, and between active citizenship and critical thought and strategies;
- Fully realizing the potential for programs to achieve excellence in quality;
- Providing the best possible student experience, from recruitment to post-graduation;
- Systematizing access and inclusion in all aspects of Faculty's work and addressing issues including indigenization and gender imbalance in disciplines;
- Fully realizing the faculty's research potential and making the research outputs visible; and
- Strengthening community engagement (local and global).

Some of the strategies regarding complement planning, curricular innovation and offering the best possible student expedience were also mentioned.

#### 6. Question Period

A question was raised about what was contained under strategies in the report, and how it relates to the areas of concerns regarding resources and workload. It was noted that these were presented as perspectives that have come from the collegium through consultation with departments and schools. It was mentioned that experiential education should encompass the full range of activities and forms; the intention to have a full range of experiential education within the Faculty. It was also recommended that there be administrative support for this.

A comment was made regarding the systemic barriers faced by contract faculty. It was recommended that a taskforce for contract faculty be set up to hear about some of these issues around inclusion

#### 7. Presentation: Student Engagement through SCOLAPS

The Chair of SCOLAPS gave a presentation on SCOLAPS, emphasizing its role in student engagement. The presentation is available here: <u>http://laps.yorku.ca/files/2015/04/SCOLAPS-Presentation.pdf</u>

Following the presentation, there was a discussion around the proposed name change from BAS degree to a BCom degree. It was noted there is an established curricular process in place to develop and revise programs at the University.

A question was asked about how students are elected to SCOLAPS to ensure diversity. Students can sign up for SCOLAPS and become members, with the use of a simple form. Recently there was an email campaign to gather more members, which resulted in an increase in membership.

#### 8. Reports of Standing Committees of Council

#### a) Curriculum, Curricular Policy and Standards

It was moved, seconded, and carried that the 90-credit and 120credit BA in Italian Culture be closed, effective September 2016. A minor amendment was made to the rationale for the closure.

It was moved, seconded, and carried that the Classics Course Rubric, CLST be approved.

The consent agenda was approved.

### 9. Community Consultation: Have your say on Governance: Participation

The Ad Hoc Governance Committee provided a brief update on their mandate and membership. The floor was opened for comments on how to improve participation in governance.

Members commented that the collegium has been excluded from searches for senior administrative positions and the need for open searches and transparency in the process.

Comments were made regarding the way in which members feel about how decisions are made. There is a perception that decisions are made without proper participation by the collegium. It was remarked that low participation and engagement also presents a important challenge on this issue.

A comment was made that there is a need for fostering a culture of participation and engagement within the University. It was noted that it is important to look into reinvigorating a participatory culture with which the University began.

It was noted that participation should be promoted in every department, spaces should be made to help bring faculty together, and more should be done in welcoming new faculty members into the university at the local levels.

A further comment was made regarding the nature of Council membership and that it might be a good time to start a discussion on having a representative governance model.

It was recommended that it might also be a good idea to have specific topics (i.e. online teaching) at Council, which affects all members, and have an opportunity for discussion and debate.

The Chair thanked the Ad Hoc Committee on Governance for their initiatives and for facilitating this conversation.

#### 10. Other Business

There was none.

#### Committee on Curriculum Policy and Standards Report to Council

Report 5 January 2016

#### **ITEMS FOR ACTION (1):**

The Committee on Curriculum, Curricular Policy and Standards recommends that Council approve a new minor program in Human Resource Management, effective September 2016.

#### 1. Proposal for the creation of a new minor program in Human Resource Management (HRM)

The objectives of the minor program in HRM are to provide a broad range of students coming from a number of departments, programs and faculties with core knowledge of HRM scholarship. Students will gain fundamental knowledge of subject matter falling within SHRM's expertise, learn about diversity and inclusion issues, which are relevant to Canada as a whole, and to an increasingly global world, and gain an understanding of legal and relational environments of workplaces, particularly in Ontario. Students who pursue a minor in HRM will also graduate with the required courses to seek accreditation to obtain the CHRP designation. The minor program will provide the skill set required by students who aspire to pursue graduate degrees in HRM-related fields and those seeking HRM knowledge in their workplace settings.

Students who take the courses in the minor program in HRM will increase their understanding of scientific methods used in HR to reduce bias, how to operate in a fair manner that adheres to legislation, and adding value to organizations through a strategic partnership.

The HRM Minor is aligned with the Faculty's strategic direction of developing programs that persuade students majoring on either the Liberal Arts or the Professional Studies side to adopt a Minor on the other side. The program is also designed in such a way that those who complete the minor in HRM will graduate with the required courses to seek accreditation and obtain the CHRP designation.
