'. Report of the Dean

Dean Singer introduced Didier Pomerleau as Executive Director, Strategic Planning. Prior to joining the Faculty he was with the Ontario government (primarily in the Ministry of Education and the Ministry of Training, Colleges & Universities) working in educational administration and policy analysis.

Dean Singer announced the number of advancements to candidacy among the probationary faculty members. He discussed the challenges associated with the late submissions by Units so close to the deadline.

The YUFA Merit Exercise was discussed. The Faculty-wide Merit Committee met over the last few days to discuss the applications for Merit. Dean Singer noted that the 2009 merit applications illustrated an impressive array of active teachers and researchers within the Faculty. Approximately 98% of the Committee's recommendation will be accepted by the Dean, only a few applications were flagged to ensure consistency within the process.

An update on the strategic planning process was given. Over the last while the Chairs and Directors, the Associate Deans, and the Dean have been meeting to discuss the principles related to the student and the faculty experience. It is anticipated that a draft framework document will be made available at the next meeting of Council.

Dean Singer announced that he will make available on the Faculty Council website the statistical snapshot and corresponding data for the Faculty. The documents contain important information on, and a comparative analysis of, the undergraduate and graduate students, full-time faculty and staff complement.

Associate Dean Crow discussed research within the Faculty. She noted that we are currently finished with the SSHRC standard grant season. She also encouraged participation of members to attend the upcoming Research Matters events. Research Matters events

This provides an opportunity to shape priorities and to ensure that our principles are compatible with those of the University. There has been and will continue to be extensive consultation regarding the Faculty Strategic Plan.

ITEM FOR INFORMATION:

Over the next several months, the Committee on Curriculum, Curricular Policy and Standards (CCPS), as part of its mandate, will continue to develop several policies and procedures for the Faculty of Liberal Arts and Professional Studies related to curriculum and academic standards. Some of the initiatives related to the academic standards, policies, rules and regulations for the Faculty that will be examined include:

- The grades review and approval process;
- Amendments to the grandparenting legislation;
- Faculty-based learning objectives;
- Guidelines for curriculum submissions and the development of guiding principles for curriculum approval;
- The review of certificate requirements;
- A review of the status of the alignment of the minimum major credit differentials between Specialized Honours and Honours options and hard minima across Honours options Degree Programs.

While CCPS acknowledges that the nature and scope of some of the forthcoming initiatives may entail a longer period of consultation and development than one academic year, it is the intention of the Committee, at minimum, to establish the framework for their continued development.

The Committee welcomes feedback and in the coming months looks forward to consulting with its colleagues regarding the Committee's forthcoming recommendations.

ITEM FOR INFORMATION AND DISCUSSION

1. Faculty of Liberal Arts & Professional Studies Strategic Planning Framework

The Academic Policy and Planning Committee received at its last meeting a proposal for the Faculty of Liberal Arts & Professional Studies Strategic Planning Framework. This document is intended to initiate a process of consultation regarding the development of recommendations for the Faculty Academic Plan.

APPC will be soliciting feedback on the principles as outlined in the document:

- 1. At the December meeting of Faculty Council
- 2. Through discussions in the individual departments and schools
- 3. Through discussions at one or more public forums to be held in January

In April 2009, an interim report on the Faculty of Liberal Arts & Professional Studies (LA&PS) was prepared by the antecedent Faculties of Arts and Atkinson. This report emphasised that the development of a long-term formal plan for the new Faculty was "a priority for the new Dean and colleagues in LA&PS next year." The report as submitted to the Academic Policy and Planning Coordinating Committee of Senate in April provided "relevant documentation on the significant forward planning" that occurred leading up to the launch of LA&PS. This document in itself provided "(i) an update on progress to date in creating the new Faculty; and (ii) the IRP commitments made by Arts and Atkinson on behalf of LA&PS."

Beginning in September 2009, the Dean, Associate Deans, the Chairs and Directors of the 21 Academic Units, and key members of the senior support staff met to discuss the process for the development of the Faculty Academic Plan. At their initial meetings, the Dean presented a panoramic snapshot of the newly merged Faculty. These data were subsequently provided to Academic Policy and Planning for its consideration and feedback. They serve as background information for further discussions on the priorities for the Faculty.

Emerging from these preliminary discussions were five fundamental areas to be addressed within the Faculty: the Student Experience; the Faculty Experience; Programs (both undergraduate and graduate); the Faculty's relations with external communities; and the distribution of the resources that supply all Faculty activities. The Proposed Faculty of Liberal Arts & Professional Studies Strategic Planning Framework

(http://www.yorku.ca/laps/council/faculty/documents/LAPSStratPlanningFramework.pdf

) expresses the strategic goals and guiding principles of the Faculty as they relate to each of the five key areas identified above.

The Academic Policy and Planning Committee discussed at length the governance process for the Strategic Planning Framework and the governing principles outlined within. It was determined that

the Strategic Planning Framework should be sent to Council for enhanced consultation and consideration prior to approval.

Throughout the Arts and Atkinson restructuring process a commitment was made to ensure that full consultation within the Faculty transpired. It is with this principle in mind that the Committee recommends that extensive consultation be undertaken prior to the January meeting of the Faculty Council.
