**1. Call to order and approval of agenda**

The Chair of Council called the meeting to order.

It was moved, seconded, and carried that the agenda be approved.

**2. Chair of Council's Remarks**

The Chair noted that a request had been received to add an item to the agenda regarding co-curricular transcripts. The item will be taken up under Other Business.

The Chair reminded Council that the 2010 United Way Campaign is currently underway and communications have been sent to members of the LA&PS community.

The Chair invited Council members to a reception immediately following this meeting of Council, and extended best wishes to the LA&PS community for a safe and happy holiday season.

**3. Minutes of the October 7, 2010 meeting**

It was moved, seconded, and carried that the minutes of the November 11, 2010 meeting of Council be approved.

**4. Inquiries and Communications**

The Chair noted that the Report of the Chair of the Council of Masters is included in the agenda package, and thanked the Masters for their thoughtful submission.

The Chair noted that the Report of the Faculty Representative on Senate was available at the front of the room.

**5. Special Presentations**

There were none.

**6. Report of the Dean**

Dean Singer announced and extended his congratulations to the recipients of the 2010 Dean's Award for Excellence in Teaching: Professor Tom Cohen (tenured category), Professor Gale Vanstone (untentured category) and Alison Hosel (contract category).

Dean Singer updated Council on the 2010 Merit Exercise. 182 applications were received and 140 awards were distributed. Dean Singer thanked the members and alternates of the Merit Committee for their hard work in completing the exercise.

Dean Singer updated Council on the progress of full-time faculty hiring. 13 tenure-track searches are currently underway. A search committee will be established for each, and all shortlisted candidates will be interviewed by the Dean. In the event that a search

committee concludes that there are no applicable candidates, the search may be extended or undertaken the following year. It was noted that within the next 10 years, assuming that eligible retirements are taken up, LA&PS would include only 400 faculty members, down from our 600 today.

Dean Singer has met with the Undergraduate and Graduate Program Directors in one third of the academic units to discuss demographics, enrollments and resources to best inform a 10-year faculty hiring plan. The meetings emphasize space planning, fundraising and resources for graduate programs. The Dean endeavours to meet with all units by the end of the month.

Dean Singer invited LA&PS staff to a luncheon on Monday, December 6 from 11:30am-1:30pm in the Founders Assembly Hall.

Finally, Dean Singer extended his best wishes to members of the LA&PS community for a safe and relaxing holiday season.

## **7. Question Period**

Members asked if the certificate proposals currently under review by the Committee on Curriculum, Curricular Policy and Standards had been forwarded to the Provost. It was clarified that amendments to the proposals have been sought by the Committee, after which time they will be forwarded. Associate Dean Kim Michasiw will provide a more detailed report of major program proposals in a future meeting of Council.

Members queried the allocation of resources for the large percentage of faculty members who may retire in the next 10 years. Dean Singer indicated that the plan is to hire new faculty to build on the existing strengths of the academic units.

The report was approved by consent.

## **9. Other Business**

Councillor Ashton addressed Council on co-curricular transcripts, an official record of a student's extra-curricular activities. ITEM FOR ACTION (1):

Proposed Changes to the Canadian Studies Program

*The Committee on Curriculum, Curricular Policy and Standards recommends that Council approve the proposed changes to the Canadian Studies program (effective Fall 2011).*

Several changes are proposed to the Canadian Studies program. Numerous changes are editorial revisions to the calendar copy. These include:

1. the addition of a note clearly explaining that Canadian Studies students must meet departmental prerequisites to take the courses listed in the calendar;
2. the addition of a note to emphasize that students may count a given course only once towards their program requirements, even if the course appears in more than one “key area”;
3. the addition of text to the calendar copy to ensure students take courses from more than one subject area when choosing courses from the available lists.

Additionally, several courses, across a variety of disciplines, are being added to the three “key areas” of the program. This will emphasize the program’s breadth and provide a greater number of course options to students. Evidence of consultation with the various Units is on file.

Furthermore, a change is also proposed to the name of the first “key area” of the Canadian Studies program. The change from “Canada: Time and Place” to “Canada: Environment (Time, Place and Space)” will better reflect its interdisciplinary nature.

**Report 1  
January 2010**

**ITEM FOR ACTION (1):**

The Dean's Award for Excellence in Teaching highlights contributions made to the enhancement of the student learning experience. It also recognizes the commitment to building a stronger teaching community in the Faculty of Liberal Arts & Professional Studies (LA&PS). The Committee on Teaching and Learning therefore recommends that Council approve the revised terms of reference of the Dean's Award for Excellence in Teaching and the creation of the Dean's Teaching Excellence in Leadership Award, Dean's Teaching Excellence in Social Justice Award, Dean's Teaching Excellence in Innovation Award, Dean's Teaching Excellence in Accessibility Award, Dean's Distinguished Nominees and Distinguished Teachers, effective Fall 2011.

**Rationale:**

The Committee on Teaching and Learning propose an expansion of the teaching awards to signal support of culture that recognizes and supports teaching excellence in Faculty of Liberal Art and Professional Studies. Drawing on discussions from last year as we developed a policy framework for LA&PS, we believe this broader range of awards allows us to signal some of the priorities we believe LA&PS should highlight in teaching and learning. We also see these awards as having an impact in the community, since we tie them to significant recognition and dissemination of excellent teaching practices anchored in teaching research and evidence of teaching practices that promote student engagement and deep learning.

The focus for these awards will be on undergraduate teaching, since graduate teaching is recognized in a separate award. From our experience this year, we want to keep the criteria as open as possible to allow the committee to fully consider relevant factors. We will be reviewing and refining these criteria based on the report from the Committee on Teaching and Learning representative each year.

**Dean's Awards for Excellence in Teaching**

**Terms of Reference**

**Purpose**

To encourage the growth of a teaching culture in the Faculty of Liberal Arts and Professional Studies that promotes the following:

- Widespread development of evidence-based teaching practices in LA&PS
- Broad promotion and adoption of excellent teaching practices that foster deep, engaged learning
- Development of key principled learning objectives that unite and distinguish LA&PS
- Recognition of teaching excellence in the LA&PS community and beyond
- Exchange of best practices among faculty and TAs across departments and units

**Criteria**

The salient criteria for each award are as follows:

### a) Dean's Award for Teaching Excellence

This award will be offered each year in three categories: tenured faculty, tenured-stream faculty and contract faculty.

**Purpose:**

The award recognizes exceptional teaching within the Faculty of Liberal Arts and Professional Studies.

**Eligibility:**

Nominations are open to all tenured, tenure-stream and contract faculty.

**Criteria:**

- Evidence of deep and sustained student learning
- Evidence of support for student growth and development
- Clear and appropriate learning objectives
- Alignment of learning objectives and priorities with teaching methods, assessments and assignments
- Willingness to collaborate with the Committee on Teaching and Learning and the Centre for Support of Teaching to publicize information about their teaching practices to the LA&PS community through a workshop, presentation, interview, video, publication or other appropriate means.

### b) Dean's Award for Teaching Leadership

One award will be offered every other year beginning in 2011.

**Purpose:**

The award recognizes exceptional leadership in faculty members who develop and or share effective teaching practices and improve the teaching culture of the Faculty of Liberal Arts and Professional Studies community.

**Eligibility:**

Nominations are open to all tenured, tenure-stream and contract faculty.

**Criteria:** Meet the criteria of the Dean's Award for Teaching Excellence as well as;

- Teaching development activities including, workshops, curricular development, presentations, etc. in the York community and beyond
- Conducting and disseminating research on the scholarship of teaching and learning
- Evidence that these development and research activities have had a positive impact on teaching and learning practices and student engagement

### c) Dean's Award for Teaching Social Justice Award

One award will be offered every other year beginning in 2011.

**Purpose:**

The award acknowledges social justice as a crucial learning objective in the Faculty of Liberal Arts and Professional Studies' and recognizes faculty members who excel in teaching effectively to this end.

**Eligibility:**

Nominations are open to all tenured, tenure-stream and contract faculty.

**Criteria:** Meet the criteria of the Dean's Award for Teaching Excellence as well as;

- Evidence of teaching practices that promote social justice
- Evidence of deep and sustained student learning about social justice
- Clear and appropriate learning objectives related to social justice
- Alignment of social justice learning objectives and priorities with teaching methods, assessments and assignments

#### d) Dean's Award for Teaching Innovation

One award will be offered every other year beginning in 2012.

**Purpose:**

This award acknowledges the challenge, risk and effort involved in teaching innovation recognizes faculty members who excel in improving student learning through teaching innovations.

**Eligibility:**

Nominations are open to all tenured, tenure-stream and contract faculty.

**Criteria:** Meet the criteria of the Dean's Award for Teaching Excellence as well as;

- Evidence of the development of effective innovative teaching practices
- Innovation guided by research in the scholarship of teaching
- Evidence that innovations improve student learning

#### e) Dean's Award for Teaching Accessibility

One award will be offered every other year beginning in 2012.

**Purpose:**

The award acknowledges accessibility as a crucial factor in promoting engaged learning for all our students and recognizes faculty members who excel in effectively teaching to this end.

**Eligibility:**

Nominations are open to all tenured, tenure-stream and contract faculty.

**Criteria:** Meet the criteria of the Dean's Award for Teaching Excellence as well as;

- Evidence of excellent and effective teaching practices and adaptations that promote the ability of students with disabilities to fulfill learning objectives
- Evidence of effective teaching practices making learning accessible for all students
- Evidence of promotion of the rights of students with disabilities

#### f) Distinguished Nominees

The adjudication committee will identify nominees from the Dean's Awards in Teaching Excellence nominees who demonstrated excellence in teaching though they may not have been selected for an award.

### Nominations

Faculty members or students may nominate a candidate on-line. No self nomination is permitted.

Candidates who have been nominated will be notified, told how many people have nominated them, and asked to submit a file for consideration.

### File Preparation

Nominees will be asked by letter to forward an application package not exceeding 35 pages which will include:

1. A cover letter (1 page)
2. Table of contents (1 page)
3. Teaching dossier<sup>1</sup> (10-15 pages)

- i. includes a statement of teaching goals and beliefs (1-3 pages),
- ii. examples of the methods used to achieve those goals relevant to the award
- iii. evidence of success in meeting the goals (can reference letters and course evaluations)

4. Letters of Support – sent directly to committee’s secretary

**i. Discipline Expert’s Letter:**

The letter from a discipline expert will focus on teaching and learning issues which can only be addressed from the perspective rigour and academic appropriateness of the discipline. Ideally this person will be familiar with the course outlines, required readings, assignments of the nominee. Evaluation of classroom practices is welcome, but not necessary. The discipline expert can be from York or outside of York. They should assess the evidence and comment on:

- Appropriateness of the learning objectives of courses for the discipline
- Appropriateness of the academic content for the level of the courses
- How well courses address relevant issues in the discipline.
- The unique challenges of teaching particular courses in the discipline and how effectively the nominee address these challenges.

**ii. Teaching Colleague:**

The teaching colleague will focus on an evaluation of the effectiveness of pedagogical practices. This colleague should be familiar with the course outlines, required readings, assessment practices and classroom practices of the nominee. The colleague can be from York or outside of York. They should assess the evidence and comment on:

- Are the learning objectives clear?
- Are the teaching methods effective?
- Are the teaching methods well aligned with the course learning objectives?
- Are the assignment design and assessment tools aligned with course objectives?
- Are the learning objectives for the course met?

**iii. Chair, Undergraduate Director, or Program Coordinator**

- Are the learning objectives of the course appropriate to the program?
- In the context of the program, are the learning objectives of the course met?
- Comment on the course evaluation results.
- Comment on any particular pedagogical challenges this instructor worked with or overcame.

**iv. Student letters** (from students who have been taught by this instructor). Nominees and faculty reviewers should be able to view all the student letters submitted to the secretary of the committee. The nominee will select a maximum of three representative samples of the student letters to be included in the file. Students letters should clearly state:

- In what capacity do you know this instructor?
- What are some specific examples of significant learning experiences you had with this instructor?
- What significance or impact has this learning had on your life?
- How has this instructor has guided, mentored or supported your learning?
- Any additional comments you would like to make about this instructor?

5. Course Evaluations

Course evaluation results should be presented in a consistent fashion, using the attached summary form (see Appendix A).

- a. Tenured Faculty: Complete the summary form, including summary data for all course evaluations in the past five years, indicating the standard teaching load in your unit and explaining why any course data may be missing.
- b. Untenured and Contract Faculty: Complete the summary sheet including summary data for all courses you have taught in the past five years. Explain why any course data is missing.

### **Adjudication Committee for the Awards**

The Committee on Teaching and Learning will appoint members to the Adjudication Committee who will recommend candidates to the Dean based on the following:

1. Faculty members who have distinguished themselves in teaching including:
  - One YUFA from the humanities
  - One YUFA from the social sciences
  - One YUFA from professional studies
  - One contract faculty member
2. Two student representatives recommended by the LA&PS Student Council.
3. One ex-officio representative from the Teaching and Learning Committee who will report on the process of deliberation.

### **Recognition**

#### **Dean's Awards in Teaching Excellence:**

Recipients from the various awards of the Dean's Awards for Teaching Excellence will be recognized in the following way:

- All awards announced in Faculty Council
- Award winners published on the Faculty of Liberal Arts and Professional Studies website
- A LA&PS Award Plaque for the Dean's Excellence in Teaching Awards will be created and placed in a prominent place. Names will be added yearly.
- Publication of LA&PS winners on the Center for the Support of Teaching website
- Consideration of wider publicity of Award winners (local papers, convocation, etc.)
- A reception will be held to recognize teaching award winners
- In collaboration with the CST as appropriate, an event should be organized to publicize the teaching practices of each of the winners.
- Winners will be recognized by a citation read at convocation

#### **Dean's Distinguished Teachers**

The Dean will recognize those nominees who demonstrated excellence in teaching though they may not have been selected for the award. They will each receive a letter congratulating them for their teaching excellence and be encouraged to apply again for this award in the coming year. They will be included in the reception above. In collaboration with the CST as appropriate, they should also be invited to present their teaching practice in some fashion if the adjudication committee recommended this.

#### **ITEM FOR INFORMATION:**

The Committee on Teaching and Learning will begin working with departments in soliciting their comments on the following proposed award:

#### **Distinguished Teachers Award (by Department)**

This award is based on benchmark criteria from course evaluations. In consultation with the Committee on Teaching and Learning, departments will set benchmark criteria from course evaluations to recognize their good teachers and TAs. A benchmark may differ by year level, type of course, etc.

This award should be recognized:

- through listing on the LAPS departmental web sites and in a prominent place;
- through listing in the Department reception areas so students can readily find this information;
- at Departmental Council meetings and unit receptions;
- when course evaluations come in, instructors and teaching assistants who pass the benchmark should be notified by letter from the Chair ;
- on the Centre for the Support of Teaching web site;

The Teaching and Learning Committee will facilitate sharing of best practices for recognizing teaching excellence.

**1. University Academic Plan 2010-2015: Enhancing Academic Quality in a Globalized World**

In October 2010, the Academic Policy, Planning and Research Committee (APPRC) of Senate initiated the first step of the renewal exercise for the University Academic Plan by inviting the community to complete a survey that provided an opportunity to comment on a variety of academic planning issues.

In January 2011, the APPRC issued a draft of the University Academic Plan 2010-2015 to all Faculties. This draft reflects feedback from the survey conducted in the autumn, and has been prepared for a final round of consultations. Following a review of this documentation by the Academic Policy and Planning Committee of Council, we are inviting comments and feedback from the LA&PS community that might seek to inform the UAP.

Feedback and comments regarding the UAP are due by no later than February 10, 2011. Given that this date coincides with that of Faculty Council, representatives from the Office of the University Secretariat and the APPRC will be in attendance to hear the debate. **2. Senate Policy on the Chartering and Review of Research Centres and Institutes (“Organized Research Unit Policy”)**

In the March 2009, under the direction of the (former) Senate Committee on Research and the Office of the Vice-President Research & Innovation (VPRI), a working group was formed to examine the various contributions that organized research units (ORUs) and their members make to scholarship, the intellectual community, and the reputation of the University. The result of this effort was a report that summarized five key findings as they relate to ORUs, which was presented to the Academic Policy, Planning and Research Committee (APPRC) of Senate in April 2010. This report informed the VPRI, who subsequently recommended that changes be made to the Senate *Policy on the Chartering and Review of Research Centres and Institutes*.

These changes were examined and endorsed by the APPRC in November 2010. In order to facilitate the next stage of consultation with Faculties, the APPRC issued a consultation document and a draft of the revised policy on December 21, 2010. Following a review of this documentation by the Academic Policy and Planning Committee of Council, we are inviting comments and feedback from the LA&PS community that might seek to inform the revised policy. These comments will then be forwarded to the APPRC for discussion by no later than February 15, 2011. The revised policy will subsequently be brought before Senate in March 2011.
