## Faculty of Liberal Arts & Professional Studies Strategic Plan

The Academic Policy and Planning Committee recommends that Council adopt the Strategic Plan for the Faculty of Liberal Arts & Professional Studies 2010-2020: Making Choices For Our Future.

The "Faculty Strategic Plan" completed by the Dean's Working Group on Strategic Planning was forwarded to the Academic Policy and Planning Committee for discussion and dissemination. Over the last month enhanced consultation within the Liberal Arts & Professional Studies community has been undertaken. Academic Policy and Planning Committee through various fora heard from community members and received feedback about the Strategic Plan. The "Faculty Strategic Plan" (not the companion appendices) is being brought forward to Faculty Council for its adoption.

The "Strategic Plan" builds upon the principles explored in the "Strategic Planning Framework" document, approved January 2010. The Plan focuses on the five goals and 29 principles that work toward building a stronger more transparent Faculty. It also speaks to the challenges and opportunities that the Faculty will face over the coming years and explores viable options to ensure that as a Faculty we progress towards excelling in our teaching and research, building our reputation both locally and internationally, while improving upon the overall student experience.

What does it mean for Council to adopt the "Strategic Plan"? The adoption of the "Plan" will set the stage for the next 10 years of planning within the Faculty. It will also initiate the third phase of the strategic planning exercise. The third stage involves a series of resource-related implementation documents which will be drawn up in consultation with the Dean's Working Group on Strategic Planning and presented to Council as items for information.

Notably, each year the Dean will be reporting annually on the progress towards achieving the goals set out in the "Faculty Strategic Plan" to Council.

The Academic Policy and Planning Committee is grateful to all those who have participated in the strategic planning process, and looks forward to working in tandem with the Dean to oversee the coordination and implementation of the "Plan".


