# 7. Report of the Chair of the Council of Masters

S. Tweyman discussed the successful breakaway sessions held over the winter term. He noted that all of the Liberal Arts & Professional Studies Masters have met with Dean Singer. He also noted that the problems with the residence suites still exist. There have been discussions with the Vice-President Academic & Provost around the White Paper and Green Papers with respect to the residences and colleges.

### Question Period

A question was raised regarding the two strategic planning community forums that were videotaped and if those who attended were advised of the taping.

The Chair noted that at the beginning of each forum an acknowledgement was made of the videotaping of these sessions. He indicated that the request not video tape assemblies will be taken under advisement and will be forwarded on to the Executive Committee for their consideration.

Members questioned why the colleges are losing residence suites. The Residence Life Coordinators no longer report to the Masters; and the University housing situation is an ongoing struggle. It was noted that these residence suites are important for commuting students, especially around exam time when some students have back-to-back exams and need a place to rest. It was also noted that there is an ongoing discussion regarding the use of space on campus.

It was moved, seconded, and carried that Council adopt the Strategic Planning Framework for the Faculty of Liberal Arts & Professional Studies. There were seven votes against the motion.

### **ITEM FOR ACTION:**

The Committee on Research Policy and Planning recommends that Council approve the Faculty of Liberal Arts & Professional Studies (LA&PS) Minor Research Grant effective May 2010.

### Faculty of Liberal Arts & Professional Studies (LA&PS) Minor Research Grant - Terms of Reference

The Faculty of Liberal Arts & Professional Studies (LA&PS) Minor Research Grant program is the adjudicative vehicle through which LA&PS dispenses the YUFA Faculty/Library Research Grant Funding and the YUFA Junior Faculty/Librarian Fund. (See sections 19.29a and 19.29b of the YUFA collective agreement.)

Deadlines: April 19 and Nov 15

### Eligibility

- Full-time (tenured/probationary appointments) YUFA faculty members affiliated with the Faculty of Liberal Arts & Professional Studies may apply to the LA&PS Minor Research Grant program as long as the project for which they are seeking funding is not already funded by an external grant.
- CLAs and SRCs in LA&PS will also be considered, but given lower priority. (Appointments for the grant period must have been confirmed by the application deadline)
- Retired YUFA faculty members from LA&PS or its antecedent faculties who are eligible to teach will also be considered, but given lower priority.
- Visiting professors affiliated with YUFA are **not** eligible.
- CUPE Unit II and CUPE Exempt Contract faculty members are not eligible for funding through this program
- Team applications are eligible for consideration as long as all applicants are YUFA faculty affiliated with LA&PS. Team applications should indicate how any funds awarded should be divided up among the applicants.
- Members of the Faculty Committee on Research Policy and Planning (CRPP) and/or its sub-committees are not
  eligible to apply for funding through this program while sitting on the committees.

### **Amount and Frequency**

The maximum amount eligible faculty members may receive from this program is \$4,000 over a period of 2 fiscal years. (The fiscal year runs May 1 to April 30).

Applicants who receive any level of funding cannot apply again until the 2-year fiscal period expires. (For example, if you were successful in the Nov 2010 deadline, you are not entitled to apply again until the Nov 2012 deadline).

Applications for projects which have previously received funding through this program or which have external funding will be given secondary priority by adjudicators.

### **ITEM FOR INFORMATION:**

Since September, the Committee on Research Policy and Planning (CRPP), as part of its mandate, has continued to develop several policies and procedures for the Faculty of Liberal Arts and Professional Studies related to Faculty-based research, while continuing to adjudicate internal research grants. The Committee would like to provide Council with the following list of initiatives that have been in development by the Committee over the last few months. The Committee:

- Provided a response to the Strategic Planning Framework
- Developed terms of reference for the minor research grant
- Constituted a Sub-Committee on the Provostial White Paper
- Is developing the Ethics Review Process for Research Involving Human Participants Faculty Policy and Procedures
- Is developing an Undergraduate Student-Professor Collaborative Research Program
- Is developing Policy and Procedures Concerning Risk Management for Students Undertaking Field Study
- Reviewed and will be modifying the current Mandate of the Committee
- Reviewed and drafting the terms of reference for research awards

While CRPP acknowledges that the nature and scope of some of the initiatives may entail a longer period of consultation and development than one academic year, it is the intention of the Committee, at minimum, to establish the framework for their continued development.

The Committee welcomes feedback and in the coming months looks forward to consulting with its colleagues regarding the Committee's recommendations.
