#### 1. Call to Order and Approval of Agenda

The Chair of Council called the meeting to order.

It was moved, seconded and carried that the agenda be approved.

#### 2. Chair of Council's Remarks

The Chair of Council discussed the approval of the nominations for next year. He thanked the Chairs and Directors and the Executive Committee for all their hard work in creating a slate of nominations that is reflective of the diversity of the Faculty.

It was not edt hat the Executive Committee at their last meeting approved a special meeting of Council for the Fall. The date of the

meeting is **Thursday**, **September 13**, **2012**. Additionally, the Executive Committee has been committed to reviewing the rules and procedures of C ouncil on e f inal t ime for an anticipated December 2012 approval at Council.

The C hair not ed t hat there will be a Committee of the Whole discussion at this meeting on the teaching and learning report to Council.

The consent agenda was approved.

#### 3. Minutes of the March 8, 2012 Meeting

It was moved, seconded, and carried that the minutes of the March 8, 2012 meeting of Council be approved.

#### 4. Business Arising from the Minutes

There was no business arising from the minutes.

#### 5. Dean's Remarks

Dean S inger d iscussed the h iring of full-time faculty — 17 tenure track professors. Currently, the Faculty has hired 12 tenure stream faculty members, one offer is with the President's office, one search is in progress, and three searches will be continuing next year.

He d iscussed the C ontractually Limited A ppointments (CLAs), a number of the appointments are renewals (26), and the Faculty is searching for another 31 appointments which are at various stages of the process.

There are 39 c ases of t enure and promotions for 2011-2012, of these 36 ha ve been received. The D ean I etter of t ransmittal h as been completed for 34. Two files are at the reconsideration phase. Promotion cases have not yet been reviewed, it is anticipated these will be done in June.

The D ean d iscussed t hat t he b udget s ituation i s a s ource of continuing concern. The Faculty has been growing and its budget has been decreasing. In the last three years the Faculty has grown

10%, with a significant portion of these being international students. The Faculty has seen 18 full-time faculty retirements and one which left for other reasons. He has been consulting with the Chairs and Directors regarding a plan for new tenure track hires (if a call is made by the Provost for new academic appointments).

On the Faculty's student enrolments, LA&PS summer enrolments are modestly a head, about 100 F TEs, projecting about 300 0 F TE for enrolments overall. For the Fall, the Faculty's applications are up 8.4%. The LA&PS applications from 101 are up 14% and for 105 v isa s tudents up a lmost 3%. The Faculty's acceptances are also up by 13%.

On the external portfolio, the conference travel grant adjudications have gone through its first round of adjudications. 58 applications have been funded for a total of about \$50,000. The second round of the seed grant funding is underway; the deadline to submit and application is **June 1, 2012.** 

On the research front Professor James Carle was honoured with the P anzer F ellowship Q ueens D iamond J ubilee medal. The Faculty's SSHRC application while down in a num ber overall the success rate was above the national average.

Dean Singer announced that the School of Social Work is located on the 8<sup>th</sup> floor of the Ross building. The School of Social Work was previously located in Kinsmen Building.

The Dean discussed that he has just received the draft version of the space plan for the Faculty.

#### 7. Reports of Standing Committees of Council

#### 7.1. Executive Committee

It was moved, seconded and carried that the nominations for Vice-Chair of Council and Faculty Council Standing Committees be closed.

It was moved and seconded that the nominations for the Liberal Arts & Professional Studies Faculty Representative on Senate be closed.

Professor Kym Bird, Department of English was nominated for the Liberal Arts & P rofessional S tudies F aculty R epresentative on Senate. She accepted the nomination.

The motion carried.

It was moved, seconded and carried that the nominations for the Liberal Arts & Pr ofessional S tudies F aculty R epresentative on Senate: Sub-Committee on Honorary Degrees and Ceremonials be closed.

#### 7.2. Academic Policy and Planning

It was moved, seconded and carried that a distinct rubric for the Gender and Women's Studies un dergraduate program, GWST be approved.

It was moved, seconded and carried that a proposal to create a distinct rubric for the Multicultural and Indigenous Studies undergraduate program, MIST be approved.

It was m oved, s econded and c arried t hat Council approve a proposal to allow Pre-University (Pre-U) Humanities, Pre-U Social Science, and Pre-U Bridging Program for Women courses offered through t he F aculty of Li beral A rts and Professional S tudies completed with a grade of "B" or better to be counted as a 3.00 elective degree-credit u pon t he admission of t he s tudent to York University.

# 7.3. Committee on Curriculum, Curricular Policy and Standards

It was moved, seconded and carried that the proposal to change the name of the General Certificate in Women's Studies to General Certificate in Gender and Women's Studies be approved.

It was moved, seconded and carried that the proposal to change the name of the Advanced Certificate in Women's Studies to the Advanced Certificate in Gender and Women's Studies be approved.

8. Committee of the Whole: Committee on Teaching and Learning – "A New Model for Teaching and Learning Support at York"

It was moved seconded and carried that the Council meeting move to a Committee of the Whole. Members from the working group were present at the meeting to discuss the document.

The document "A New Model for Teaching and Learning Support at York" was presented for an open discussion. The floor was opened to questions.

In light of the closure of the Centre for Support of Teaching (CST), how will this new structure address the problems with the CST?

For some time the re-visioning working group deb ated about the outcome. It was noted that this is not a centralized service more of a sum of its constituents. There will be two Educational Developers and partnership arrangements made with the Faculties. It will offer a Teaching Commons over and above what the CST did and listen to the needs of teaching. The working group is continuing to consult with colleagues on the development.

It was noted that the working group can not speak to the reasons for closing the CST, but services that were offered through the CST will continue. The CST Director was a member of the faculty. The Teaching Commons will have longer term appointments and there will be Educational Developers hired.

A question was raised about the support that was given to Teaching Assistants (TA) and graduate students through the CST and if it will continue.

It was discussed that plans were underway to have TA days and that communication is forthcoming regarding this. Further programs for graduate students are under development as well.

A question regarding the Educational D evelopers and where they originated from was asked. It was noted that they have a variety of backgrounds and have a commitment to teaching.

A question regarding the resources of the Teaching Commons was asked. There is a t otal commitment to addressing the issues of resources for the Teaching Commons. It was discussed that clarity is need ed on the effects of the eaching in a nat mosphere of constrained resources.

The regular scheduled meeting time elapsed before the committee of whole discussion came to a close and since quorum was not met the meeting did not continue.

#### 9. Other Business

The Chair of the Committee on Research Policy and Planning announced that the Committee is developing a working paper series and a Dean's Award for Excellence in Research.





# Synopsis of the 585<sup>th</sup> Meeting of Senate held on June 28, 2012

#### Remarks

The Chair of Senate, Professor William van Wijngaarden:

- saluted those who had made the Spring Convocation ceremonies so memorable and inspiring
- thanked all Senators, especially those who terms were ending, outgoing Chairs of Senate Committees, and Senators who were retiring from the University
- expressed condolences on the passing of Professor Varpu Lindstrom
- advised Senators that they would be invited to participate in a year-end governance survey

#### President Shoukri commented on:

- his gratitude to the leadership of Senate at the conclusion of a positive and productive year
- successful Convocation ceremonies which saw the introduction of the "name card" captioning for the 6,300 students who attended in person
- the launch of consultations by the Premier on the future of postsecondary education in Ontario coinciding with the release of a discussion paper entitled "Strengthening Ontario's Centres of Innovation, Creativity and Knowledge"
- the University's financial outlook and efforts to foster greater transparency and sustainability through PRASE initiatives and the budget modeling exercise
- an increase of 7.5 per cent in summer enrolments following a campaign aimed at York students and those studying elsewhere who have enrolled on letters of permission
- recent accomplishments by members of the University community, including the country-leading success rate for first-time applicants for NSERC grants
- the re-appointment of Dean Alice Pitt and Dean Deszo Horvath, the appointment of Janusz Koziński as the first Dean of the Lassonde School of Engineering, and the appointment of Don Hastie as the Acting Dean of the Faculty of Science and Engineering
