Please note that awards are intended to provide support to eligible undergraduate students for their upcoming global and community engagement study. **Retroactive applications will not be considered**.

FREQUENCY OF REQUEST:

- Students are eligible for one (1) award within the academic year
- A maximum of two (2) awards in duration of their studies, where one is associated with a student exchange program.
